PC2223/086 Clerks Report

Due to illness the Admin Officer had been unable to attend to clerk the meeting and as such was unable to provide a Clerks report. A number of issues were discussed that had been raised with the Chair by the officer within since the last meeting:

• emails received from local resident Mr Batley were discussed. It was noted that Ward Cllr Pollard has responded to all of the points raised by Mr Batley. The Planning committee chair agreed to dictate a letter to be sent to Mr Batley acknowledging his work and commitment but expressing the limitations of the planning committee at Baildon Town Council.

The Baildon Plan. The committee agreed to put the Baildon Plan on hold until later in the year as there were currently more pressing priorities within BTC, a lack of available time and available personnel.

The Neighbourhood Development Plan. It was recommended that a date should be set to discuss where we are at currently within the process.

Cllr Foster reported back from her attendance at the Design Code meeting in Bradford at The Great Victoria Hotel. Broadbent to enquire about the process from May onwards. It was evident that the 18-24 age group is under represented within the discussions being held.
