23/02865/FUL Conversion of existing outbuilding to form new dwelling 1 Cecil Avenue Baildon West Yorkshire BD17 5LH

Resolved to make the following comments:

1 Cecil Avenue is one of the stone-built properties that gives Baildon its character and so the Town Council is concerned to see a proposal to build a dwelling in its garden.

The applicant acknowledges that 1 Cecil Avenue "was constructed at the turn of the 19th / 20th Century and is an attractive, imposing property, with a feature turnet on the front (South-West) corner, along with

some attractive stone features, banding, large double windows with central stone mullions, heads and cills, and imposing chimney stacks."

The proposal diminishes the pleasing aesthetics of the plot, reducing its garden area significantly with a consequent reduction in green space and trees.

The proposal overdevelops the plot and places the proposed new dwelling very close to existing neighbours on Collier Lane with loss of amenity for them.

The proposal includes a new access and driveway on to West Lane, a very busy arterial road in Baildon. BTC could not encourage the building of a new driveway here, so close to the junctions with Cecil Ave and Collier Lane.

There will be loss of biodiversity and natural habitat arising from this development.

Baildon Town Council objects to this application.
